1. Opening of the Meeting

The Chair, Alex Kinninmonth (UK), will open the meeting.

Members of the Commission and NGOs may make verbal Opening Statements, as is usual in years when new regulatory measures are negotiated. It would be helpful if the written versions of any verbal opening statements could be sent to the Secretariat by 7 June 2024 so that they can be annexed to the final meeting reports.

2. Adoption of the Agenda

A Provisional Agenda, <u>NEA(24)01</u>, was issued on 16 February 2024. No supplementary items were proposed by the Parties. The Draft Agenda, <u>NEA(24)02</u>, was issued on 5 April.

3. Nomination of a Rapporteur

4. Report of the ICES Advisory Committee on Salmon Stocks in the Commission Area

In 2022 the Council agreed that full ICES Advice should be presented in Council only in future, <u>CNL(22)53</u>. Therefore, there will be no presentation of ICES advice during the Commission meeting.

However, Article 9 of the Convention states that 'In exercising the functions set out in articles 7 and 8, a Commission shall take into account: the best available information, including advice from the International Council for the Exploration of the Sea and other appropriate scientific organizations...'

This agenda item allows for questions and comment on the ICES Advice, if required. The Chair of the Working Group on North Atlantic Salmon (WGNAS), Alan Walker (UK), will be available to answer questions, if required.

5. Mixed-Stock Fisheries Conducted by Members of the Commission

This is essential business under Articles 7 and 15 of the Convention. Additionally, under the Council's 'Action Plan for taking forward the recommendations of the External Performance Review and the review of the 'Next Steps' for NASCO', $\underline{CNL(13)38}$, it was agreed that there should be an agenda item in each of the Commissions to allow for a focus on mixed-stock fisheries.

Each member of the Commission with mixed-stock fisheries (MSF) was requested to provide the Secretariat with a short paper which includes a brief description of any MSFs still operating, the most recent catch data and any changes or developments in the management of MSFs.

6. **Regulatory Measures**

In 2021 the Commission adopted 'Decision Regarding the Salmon Fishery in Faroese Waters in 2021 / 2022, 2022 / 2023 and 2023 / 2024', <u>NEA(21)16</u>. Under this Decision, the Commission agreed:

'Not to set a quota for the salmon fishery in the Faroese Fisheries Zone for 2021 / 2022. This decision will also apply in 2022 / 2023 and 2023 / 2024 unless the application of the Framework of Indicators shows that a re-assessment is warranted. Denmark (in respect of the Faroe Islands and Greenland) retains the right to conduct a scientific research fishery in the Faroese Fishery Zone.'

The FWI has been used in the intermediate years of a multi-year catch agreement to provide an interim assessment of the robustness of the pre-fishery abundance (PFA) forecasts provided by ICES, and to determine whether a full re-assessment of stock status and new catch advice might be required. NASCO has previously agreed, NEA(13)11, that when the Faroese fishery is closed, the FWI should only be used to signal the need for a re-assessment where there is an underestimate of forecast abundance (i.e. when a potential harvest might otherwise be available). The rationale for this is that if the FWI signalled that PFA had been overestimated, any new assessment would be even less likely to signal a fishery option.

No fishery for salmon has been prosecuted at the Faroes since 2000 and no quota for the Faroe Islands fishery has been set since 2000. Since 2013, decisions regarding the salmon fishery in Faroese waters have been agreed for three-year periods, unless the application of the FWI shows that a re-assessment is warranted. In recent years, the duration of the Decision has been aligned with that of the regulatory measure for the West Greenland fishery. However, the current 'Multi-Annual Regulatory Measure for Fishing for Atlantic Salmon at West Greenland', WGC(22)10, will be renegotiated in 2026 at the latest. The alignment has enabled a full update of the ICES advice to be requested every three years and if the two regulatory measures remain out of synch then the full advice will have to be requested more frequently.

The Commission will discuss a new Decision for the salmon fishery in Faroese waters.

In previous years alongside agreement of the regulatory measure, a FWI Working Group has been established, with a representative from each NEA member. The Group has worked by correspondence, in years where no new regulatory measure is negotiated, to co-ordinate the data collection and apply the FWI. In those years, the Group has completed its work in January so that ICES could be advised by the end of January, if re-assessment of the catch advice is required.

However, the FWI has not been updated because its development was not requested of ICES in the 2023 Advice request, <u>CNL(23)11rev</u>. Additionally, a new assessment model has been agreed for Atlantic salmon in 2024. The Chair of the WGNAS, and two members of the NASCO FWI WG, have both confirmed that it would be possible to reinstate the FWI process in future years. However, it would not be possible for the 2025 / 2026 season. It would be possible for the 2026 / 2027 season but full advice will be available in 2026 anyway as that is the next year in which the regulatory measure for the fishery at West Greenland will be negotiated. The FWI will not, therefore, be available for at least the next couple of years for inclusion in the NEA Decision. The Commission will need to discuss the new Decision in light of this information.

The ICES summary of advice for fishing seasons 2024 / 2025 to 2026 / 2027 for Atlantic salmon from the Northeast Atlantic states (<u>CNL(24)06</u>, p 23) states:

"...in the absence of specific management objectives and when the MSY approach is applied, the catch on both the Northern and Southern North-East Atlantic Commission (NEAC) area complexes at the Faroe Islands should be zero in each of the fishing seasons 2024/25, 2025/26, and 2026/27."

The Commission may wish to:

7. Risk of Transmission of Gyrodactylus salaris in the Commission Area

This Agenda item allows for information exchange and co-operation on monitoring, research and measures to prevent the spread of *G. salaris* and eradicate it if introduced. Parties were invited to submit papers to this Annual Meeting, to report on their work on the 'Road Map' to enhance information exchange and co-operation on monitoring, research and measures to prevent the spread of *G. salaris* and eradicate it if introduced, NEA(18)08.

A face-to-face meeting on the Working Group on *Gyrodactylus salaris* was held in October 2022, which reported several recommendations to the Commission in 2023, that were agreed as best practice and the Commission encouraged members to disseminate them widely.

Recommendation 27 of the External Performance Review Panel, $\underline{CNL(23)17}$, is related to *G. salaris* and contains recommended actions to deal with the parasite. The Commission will be asked to consider this in 2025 when it considers Terms of Reference for the next meeting of the *G. salaris* Working Group.

8. Announcement of the Tag Return Incentive Scheme Prize

NASCO operates a Tag Return Incentive Scheme. External tags that are returned to the appropriate authorities in the country of capture are eligible for inclusion in the draw. Each year a Grand Prize of £1,500 is awarded together with three prizes of £1,000, one in each of NASCO's three Commission areas.

The winner will be announced at the Meeting and will be recorded in the Meeting Report.

9. Recommendations to the Council on the Request to ICES for Scientific Advice

This item is required under Article 9 of the Convention which requires a Commission to take into account the best scientific evidence. Advice is provided annually under the ICES / NASCO Memorandum of Understanding.

In 1992, the Council established a Standing Scientific Committee (SSC) to assist the Council and Commissions in formulating their questions to ICES. During the Annual Meeting, the SSC will meet to develop a Draft Request for Scientific Advice from ICES for consideration by the Commissions and the Council.

A nomination has been sought to replace Niall O' Maoiléidigh (who is retiring in advance of the 2024 Annual Meeting) as one of NEA's representatives on the SSC.

- the Commission may wish to appoint Dr O' Maoiléidigh's replacement to the SSC; and
- the Commission will be asked to consider the relevant section of the SSC's recommendation, although it may wish to defer the decision to the Council.

The Standing Scientific Committee's recommendations will be available once its work is complete.

10. Election of Officers
