The Interreg Project MIGRAMIÑO-MINHO, with the participation of Spain and Portugal, started at the end of 2016 with the aim of improving the status of migratory fish populations of the international reach of river Miño and of their riverine habitat conditions and is still ongoing.

There was a big drought again in Galician rivers during 2018 which probably affected to the final catch. No other significant changes.
