#### **1: Changes to the Implementation Plan**

No revision is proposed for the IP.

**1.2** Describe any major new initiatives or achievements for salmon conservation and management that you wish to highlight.

A new management plan for sport fisheries in river Ulla is under development. This plan intends to reorganize fishing pressure in the river and to promote catch & release fishing for salmon.

Restoration of populations in rivers from A Coruña has already begun, with the stocking of rivers Anllóns and Sor, which lost their populations in the 1950's and in the 1980's respectively.

No significant changes have been detected.
