Report of the Meeting of the Finance and Administration Committee of the North Atlantic Salmon Conservation Organization

Hotel North 2, Happy Valley - Goose Bay, Canada

Monday 1 June 2015

1. Opening of the Meeting

- 1.1 The Chairman, Mr Raoul Bierach (Norway), opened the meeting and welcomed members of the Committee to Happy Valley Goose Bay.
- 1.2 A list of participants is contained in Annex 1.

2. Adoption of the Agenda

2.1 The Committee adopted its agenda, FAC(15)6 (Annex 2).

3. 2014 Audited Accounts

- 3.1 The Secretary introduced the audited accounts for 2014, FAC(15)2. In 2014, the Committee had recognised that the Organization's financial position was much more favourable than it had been at the start of 2013. This improvement continued during 2014. During the year an unbudgeted sum of approximately £61,000 had been credited to the Contractual Obligation Fund. The loan to NASCO of £25,000 from the International Atlantic Salmon Research Board had been repaid in full in 2014 and the Working Capital Fund, which had been rebuilt in 2013, remains at its ceiling of £200,000. The Contractual Obligation Fund continues to be rebuilt, in part due to a favourable dilapidations settlement of £38,000 from the outgoing tenants of the leased property. He indicated that although the Contractual Obligation Fund remains well below the ceiling of £250,000, it should reach this level by the end of 2017, given the sums budgeted in the five-year Spending Plan. However, the immediate obligations to staff have been met. The Recruitment Fund continues to be built and currently stands at £15,000 and will increase to £30,000 by the end of 2015. The Committee agreed that the Recruitment Fund should continue to be built and be reviewed annually.
- 3.2 The Committee recommended to the Council the adoption of the 2014 audited accounts.

4. **Relationship with ICES**

4.1 In 2007, the Council had entered into a Memorandum of Understanding (MoU) with ICES that is subject to review every three years. In 2013, on the recommendation of the Finance and Administration Committee, the Council had agreed to continue with the MoU with ICES on the understanding that there would be no increase in costs during this period above the rate of inflation in Denmark. Last year, the Secretary had raised with ICES the possibility of receiving the ACOM advice earlier than the date specified in the MoU (10 May) and the 2015 advice was received prior to this date. The Committee recognised that the relationship with

ICES was working well and agreed that the MoU should continue for a further three years from 2016.

- 4.2 Last year, the Committee had noted that one of the aims in moving to multi-annual advice had been that, in years when catch advice was not needed, broader questions of relevance to salmon conservation might be included in the request to ICES. However, it had been noted that because of the need to maintain the time-series of data, limited additional time might actually have been made available to ICES in years when there is no request for catch advice. As requested, the Secretary had consulted the Chairman of the WGNAS about the time available at its meetings in non-advice years. It was noted that:
 - The annual data collation exercise and updating of time-series to provide annual feedback on the status of stocks is relatively time-consuming and since WGNAS continues to report on stock status the 'savings' in non-catch advice years are relatively modest;
 - WGNAS has also had additional work to do in recent years in developing the Faroes risk framework and a number of *ad hoc* questions (e.g. reporting on impacts of exotic salmonids; by-catch; stock classification; reviewing management objectives; etc);
 - issues under the 'threats and opportunities' question typically constitute a substantial component of the report in relation to salmon in the North Atlantic.
- 4.3 The Committee recognised that despite on-going work related to assessment of stock status, ICES had been able to address additional questions in the request from NASCO. The Secretary informed the Committee that ICES had asked for feedback on the format of the advice. The Committee did not have any substantive proposals for changes to the format, but, because answers are sometimes difficult to find, requested that consideration be given to presenting the responses to questions from NASCO in the same format as the request in future ACOM reports, i.e. responses to questions relating to a specific Commission area should be presented in that section of the ACOM report, rather than in the section relating to the North Atlantic area.

5. MoU with the OSPAR Commission

- 5.1 The Secretary introduced document FAC(15)3. The MoU between NASCO and the OSPAR Commission came into effect on 5 August 2013. It requires that: the OSPAR Commission and NASCO are invited to attend each other's meetings of mutual interest; there is an exchange of information and coordination on matters relating to salmon conservation and protection of the marine environment in the North-East Atlantic; and the Secretariats will report to their organisations on actions taken pursuant to the MoU. Since August 2013, NASCO had sent reports to the OSPAR Commission Secretariat and invited them to attend NASCO meetings. In 2014 the Committee had underscored that relevant information should flow to and from both organisations. On 7 May 2015, the Secretary of the OSPAR Commission sent NASCO a link to the OSPAR Commission reports and invited NASCO to attend the Annual Meeting of the OSPAR Commission. This was welcomed by the Committee. correspondence also included a Draft Recommendation relating to salmon developed by OSPAR's Biodiversity Committee. NASCO had not been consulted on this Draft Recommendation.
- 5.2 The Committee noted that in its present form, the Draft Recommendation fails to recognise the measures, agreements and practices developed and implemented by NASCO. The Committee therefore recommends to the Council that the Acting President be requested to write to the Chairman of the OSPAR Commission indicating that NASCO, as the RFMO charged with

conserving, managing and restoring salmon in the North Atlantic, would appreciate an opportunity for proper consultation and comment before the Draft Recommendation is adopted.

6. Review of the NASCO Tag Return Incentive Scheme

- 6.1 At its 2014 Annual Meeting, the Committee recognised that the Tag Return Incentive Scheme had brought benefits in terms of publicity for the work of the Organization and the need to return tags. The Secretary was asked to prepare a brief review of the operation of the Scheme for consideration at the 2015 Annual Meeting. The Secretary presented paper FAC(15)4).
- 6.2 The Committee decided not to make changes to the operation of the Scheme but undertake a further review of its operation at the 2018 Annual Meeting.

7. Headquarters Property

7.1 The Secretary advised the Committee that a lease had been agreed with new tenants which entered into force on 5 January 2015 at an initial rent of £40,000 per annum, with service charges payable in addition. The lease is for all the available accommodation that is not required by NASCO and is for a ten year period, with a tenant-only break option after three years and a mutual break option after 5 years. Over the period of the lease, there should be income from the property of around £550,000. There was a four-month rent-free period that ended at the start of May 2015. The new tenants had accepted the property in its present condition and a dilapidations settlement of £38,000 was negotiated from the outgoing tenants, which was credited to the Contractual Obligation Fund. The Committee welcomed the successful negotiation of this new lease.

8. Consideration of the 2016 Draft Budget, Schedule of Contributions and five-year Budgeting Plan

- 8.1 The Secretary introduced the Draft 2016 Budget, FAC(15)5. The 2016 budgeted expenditure represents a reduction compared to the five-year spending plan agreed in 2014, and the main reason for the increase in 2016 compared to the 2015 budget is the increased contribution to the Contractual Obligation Fund from £66,000 to £94,000. If that increased contribution is excluded, the budget represents a reduction in real terms of approximately 2.5% compared to 2015.
- 8.2 The Secretary was asked to explain why the 2015 budget provision for 'Meetings' had increased from £8,000 in the 2015 Draft Budget to £36,000 in the budget adopted by the Council. He indicated that this was because there had been uncertainty about whether there would be an invitation to host the 2015 Annual Meeting at the time the budget was agreed. Funds had, therefore, been included in the budget to cover the cost of an Annual Meeting in Edinburgh but subsequently Canada agreed to host the meeting. The Secretary indicated that because of the loss of income from the property and other unanticipated costs, he had not recruited a fourth, locally recruited Secretariat Member but that funds had been included in the 2016 Budget to allow for such an appointment.
- 8.3 The Committee agreed to recommend to the Council the adoption of the 2016 Draft Budget and 2017 Forecast, FAC(15)7. The Budget as adopted by the Council, CNL(15)19, is included in Annex 3. A five-year Budgeting Plan (2016 2020) was also provided for information.

9. Appointment of Auditors

9.1 The Committee noted that the Council had previously appointed Chiene + Tait of Dublin Street, Edinburgh, as auditors for the 2012, 2013 and 2014 audited accounts. The Committee agreed to recommend to the Council the appointment of Chiene + Tait for the 2015, 2016 and 2017 audits, or such other company as may be agreed by the Secretary in consultation with the President and Chairman of the Finance and Administration Committee. The Secretary indicated that he would seek three quotes for the audit work for the coming three year period.

10. Any Other Business

- 10.1 In 2012, the Council agreed to contribute a sum of £5,000 towards the cost of filming at West Greenland for the film, 'Atlantic Salmon – Lost at Sea'. The film is being produced by Deirdre Brennan, an Emmy nominated director for film and television. The Secretary reported that filming has taken place in seven countries and during the SALSEA-Merge research surveys. The film will be an excellent way of raising awareness of the challenges facing the salmon around the North Atlantic, the research programmes being undertaken and the wide range of measures that have been taken to conserve and restore them, including the international work of NASCO. The Secretary reported that to date, funding of US\$427,000 has been raised for the film, but due to a delay and uncertainty with one sponsor, a further sum of around US\$50,000 (£30,000) is now being sought to complete the post-production work. The Committee agreed that the Secretary should be authorised, subject to budgetary considerations and conditional on the remaining funding being found from other sources, to make an additional contribution of up to £10,000 from the 2015 budget. The Secretary will consult Castletown Productions with regard to seeking confirmation of the remaining work to be completed before the film can be released, the timelines for completion of this postproduction work and on progress with the 'Kickstart' fund-raising campaign and what is foreseen in case the fund raising campaign fails.
- 10.2 The Committee was advised that the current Vice-Chairman of the Committee (Mr Doug Twining (Canada)) is no longer involved in NASCO matters. The Committee elected Mr Cal Wenghofer (Canada) as Vice-Chairman to serve the remainder of Mr Twining's term (until 2016).

11. Report of the Meeting

- 11.1 The Committee agreed a report of its meeting.
- 11.2 The Chairman thanked the members of the Committee for their contributions and closed the meeting.
