Stocking of rivers Sor and Anllóns (A Coruña province) continued during 2015. Though a few grilse may have returned during 2015, first springers (the main component of our populations) will do so during 2016. The lower part of Anllóns has been declared “Free Access Catch & Release waters”

Action H2:	Description of Action (as submitted in the IP):	Following the implementation of the WFD there are several programmes ongoing aimed to the subject.

	Expected Outcome (as submitted in the IP):	“Good ecological status” for all water bodies is a general objective under the WFD. An improvement in water quality is expected. In the present moment
	Progress on Action to Date (see note above):	Only the Anllóns, Xubia and Miño rivers, among main salmon rivers, did not achieve the good ecological status and are in the moderate range. Some tributaries are in bad status.

	If Completed, has the Action achieved its objective?	
Action H3:	Description of Action (as submitted in the IP):	Implementation of compensation flows is ongoing under the guidelines of river basin management plans.
	Expected Outcome (as submitted in the IP):	Recovery of some reaches that presently are under very reduced flows or completely dry.
	Progress on Action to Date (see note above):	The new River basin plans 2015-2021 affecting salmon rivers in Galicia were approved recently, including the definition of compensation flows for every water body. The next goal is the implementation of these flows.

Action H4:	Description of Action (as submitted in the IP):	Removal of obstacles. Construction of fishways. Improvement of accessibility.

	Progress on Action to Date (see note above):	Seven dams were teared down in the Ulla basin (related to the Life+ Margal-Ulla project <i>LIFE NAT/ES/000514</i>). Construction of some fishways in the Coruña province is under study.
