Asturias: Very low illegal activities because, only fishing by anglers is allowed. All coastal fisheries are banned.

Cantabria: All rod & line catches are screened. Other salmon fisheries (nets, coastal fisheries...) are illegal.

There is not estimate for unreported illegal in-river fishing. Assessment c.5% of total catches.

Navarra: Unknown, but we consider that it is null or very low, because all catches must be declared.

The categories might include unreported catch by different gear types used for salmon fishing; by location of the salmon fisheries, e.g. coastal fisheries, in-river fisheries, etc.; and by-catch of salmon in fisheries for other species.

2.5 How many salmon were reported as being caught and released in 2007?

Cantabria: No catch & release fishing for salmon.

Navarra: Unknown, but it is not a common practice in the Bidasoa River.

Atlantic Salmon can be found in the following Spanish Autonomous Communities: Galicia, Principality of Asturias, Navarra, Cantabria and Basque Country.
