Reporting percentage amongst license holders is up 14%-points from 2022 to 2023 with a reporting percentage of 82%. The number of reports received has also increased by 28% compared to 2022.	
A new initiative for the Kapisillit salmon: The Ministry of Fisheries and Hunting, have in partnership with the Ministry of Agriculture, Self-sufficiency, Energy and Environment, started the application-process for an EU-funded project via Bestlife2030. The project will focus on conservation of the Kapisillit river and surrounding area, and thereby the Kapisillit salmon, through a focus on local involvement and management.

	Approach for monitoring effectiveness & enforcement (as submitted in the IP)	The Greenland Fisheries License Control Authority (GFLK) will continue its increased focus on monitoring and controlling the fishery and sale at open air markets throughout the period.		

		<p>Before the fishing seasons in 2019 and 2020, the Ministry of Fisheries, Hunting and Agriculture and GFLK will evaluate the reporting of the previous season and what worked and did not work of the initiatives for improved reporting and validation of the reporting. If needed, new measures will be implemented before the following fishing season.</p>

Other material (e.g. website links) will not be evaluated)</i></p>	<p>Reporting percentage has increased from 68% in 2022 to 82% in 2023. The number of reports received has also increased from 1.267 in 2022 to 1.616 in 2023.</p> <p>The number of reports received with-in season is only 44,6% compared to 84% in 2022. This change is related to a larger part of the &gt;0 catches, being reported after the close of the fishery, than in 2022. Most of these reports are still received within the 14 days limit, but do not help to contribute to the monitoring of the fishery and the decision on when to close it.</p> <p>The number of 0-catch reports received has increased from 2022 by 76%. This corresponds to the number of license holders only reporting 0-catch, which has increased by 53% from 2022 to 2023 (or constituting 45% of license holders in 2023 compared to 25% in 2022). The number of reports received between time of closure and last day of reporting has increased from constituting 23% of 0-catch reports in 2022 to 41% in 2023. In conclusion, more 0-catch reports are received during or after the season, where it is still allowed, which means that more license holders understand that 0-catch also need to be reported.</p> <p>A change in our license and reporting system, will make it possible to see the difference of when a report is received and when it is manually entered into the system by a GFLK employee. This could give a better picture of the delay in the reports received from the municipalities and via email.</p> <p>Technical issues with the online reporting system has also affected the 2023 season: reports with errors were not sent to GFLK, but got stuck in the system (see document WGC(24)03 for details). This has been fixed now and should improve the live reporting during the 2024 season.</p> <p>More valid data: this season there were several reports of catches in the Kapisillit area. Every year GFLK looks at the reports and the catch areas listed in the report. This year three &gt;0 catch reports were received from the area. All of them had listed catch areas not relevant for the Kapisillit area and should belong to the Southwest area instead. The catch came to 23,9 kilos in total.</p>

Furthermore, continuing the increased focus of the wildlife officers during the fishing season, including the locale information meetings that the wildlife officers / GFLK have each year with the municipality officials, local fishermen's organizations and individual fishermen.

These contained information about how to report and consequences of not reporting. An ad was made for both of the national newspapers in Greenland with a link to the online reporting website as well as a continuous ad on their website with a direct link to the online reporting website Sullissivik.  Text messages were sent to all license-holders both during the season with a reminder to report, and when their area was closing with a reporting deadline.  In collaboration with NASF and ASF, the Ministry managed and promoted a lottery in the citizen science programme for salmon samples to be received by the Greenland Institute of Natural Resources. A video was made by a famous Greenlandic influencer, Q's Greenland, with information about the competition and that a condition of entering the lottery was to report.  License appliers that did not fulfil the reporting requirement in 2022 were not issued licenses in 2023. This was made clear through all the information channels used for this season, as well as on the individual license.

		The GFLK wildlife officers have in their daily monitoring of the Greenlandic fishery, including the salmon fishery, promoted and recommended the online reporting system Sullissivik to the fishermen, as this is easier to communicate to the fishermen and to train them to use, rather than the manual reporting option available through the municipalities.

The project will focus on conservation of the Kapisillit river and surrounding area, and thereby the Kapisillit salmon, through a focus on local involvement and management. If the application is approved the project can start in the fall. The outcome should be a management plan for the Kapisillit river and salmon stock, and through local involvement, will help monitor and regulate the Kapisillit River stock. <b>Scientific advice for the Kapisillit river stock will be given in 2024.</b>  <b>Greenland is a part of the PINKTrack program monitoring Pink salmon through eDNA.</b>  GFLK has performed routine within-season visits to the Kapisillit area to observe that current rules are complied with.
